Campus Transformation Project

The innovative design for the New Loma Linda University Medical Center's Campus Transformation Project includes 104 Fluid Viscous Dampers by Taylor Devices. Prototype Testing and Production Testing was a requirement of the Alternate Method of Compliance for the structural design of the new hospital. As part of our inspection process, SBS performed multiple shop visits during prototype and production testing at Taylor Devices in North Tonawanda, New York. The viscous damping system will substantially reduce the stress and deflection throughout the structure. Foundations are being placed incrementally, coming up to compressive strength, and staying ahead of the steel. Underground utilities are also on track and moving forward with main services being trenched and placed.


Stamping and Signing

Back to Normal? How to Revert to Pre-COVID-19 Hospital Conditions *with OSHPD RCO John Schrenk & CO Joel Sanders*

In response to the COVID-19 pandemic, many hospitals have implemented measures to treat positive patients, including setting-up makeshift negative pressure patient rooms. With a new study conducted by the University of Oregon providing evidence of SARS-CoV-2 RNA contamination of air handling units' path of flow, reverting to original, pre-COVID-19 conditions may not be that simple. This short webinar provides a forum for authorities having jurisdiction as well as healthcare professionals, administrators, engineers, contractors, and maintenance personnel to prepare for the challenges ahead in getting back to normal within the hospital environment.
