Tower II Increment 1 building permit has been issued by OSHPD and McCarthy Builders has broken ground. Approximately 40,500 cubic yards of soil will be exported and temporary shoring will be set in place. The new structure is a bolted sideplate and the first to be used on an OSHPD project. This will greatly reduce the amount of welding and expedite installation and the construction schedule.

The healthcare construction industry can be very technical and it takes years of experience to accurately navigate through the process. Here is this week's topic that we've experienced in the past and hopefully is beneficial to you:

Plumbing Air Gaps – Common Mistakes

Where potable water is discharged to the drainage system, it shall be by means of an approved air gap of two pipe diameters of the supply inlet, but in no case shall the gap be less than 1". What we see in the field is commonly assumed that all discharge piping can be 1". Locate the source to ensure you are meeting <u>2019</u> <u>CPC 603.4.4</u>.



We also wanted to share a great tool <u>here</u> to identify the different code sections/cycles for required plumbing air gaps including different appliances and equipment. Thank you John Schrenk for providing this document and sharing it with us.
